Old Business

Laufer/360 Southbury Road – Driveway improvements

Mr. Neff presented a map entitled Driveway Improvement Plan dated 10/21/09. (This is the map presented at the regular meeting October 27, 2009, New Business.) Ms. O'Conner and Ms. Steers did the site walk. They questioned Mr. Neff about the possible increased velocity of water runoff through the rock-lined swale. Mr. Neff explained that the runoff would actually be less rapid than down asphalt, the natural stone swale sides slowing the drainage.

Motion: To approve the application of Laufer/360 Southbury Road - Driveway Improvements as a regulated activity by Ms. O'Conner. The motion was seconded by Mr. Horrigan and passed 5-0.
